All Breed International Dog Shows, Inc. Agreement

I (we) acknowledge that the Rules and Regulations of All Breed International Dog Shows (ABIDS) have been made available to me (us) on the website, and that I am (we are) familiar with the contents. I (we) agree that All Breed International Dog Shows (ABIDS) has the right to refuse this entry for cause, which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the show and the opportunity to have the dog judged and to win prize, ribbons or trophies, I (we) agree to hold All Breed International Dog Shows, Inc., their members, directors, governors, officers, agents, superintendents. show secretary or ring stewards and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death, or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft damage or injury, be caused or alleged to be caused by the negligence of All Breed International Dog Shows (ABIDS) or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and to indemnify and save the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

Judges will not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. Judges may not judge dogs owned or co-owned by them.

There will be a grooming & crating area available to exhibitors. Please crate all dogs when not in the show rings. All exhibitors are asked to have their dogs under their complete control at all times. The use of prong collars in the show ring is prohibited. The use of flexi-leads is accepted on the show grounds but you are responsible for your dog. No tie out stakes or dogs tied to bumpers or anything else will be allowed on show grounds.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by vet or judge, or barred from competition by action of the Show Chairman or Show Secretary. All Breed International Dog Shows (ABIDS) reserves the right to refuse entries. Poor sportsmanship will not be tolerated at shows. If upon pre-entering and you are not able to attend the show monies will not be refunded to you & monies may not be put towards another show. If because of riots, civil disturbances or other acts beyond control of the management it is impossible to open or to complete the show, no entry fees will be refunded. Post-dated checks or returned checks do not constitute a valid entry fee. US Postal Money Orders are not accepted.

Hotels Are Considered An Extension Of The Show Site And ALL ABIDS Rules Will Be Enforced At Both Locations. Dogs Must Not Be Bathed, Left Looser or Unattended In Hotel Rooms. Exhibitors will be held responsible for any damage to their hotel rooms. ABIDS maintains the right to refuse entries from irresponsible owner and/or handlers. PLEASE exercise dogs at the motels and the show sites in designated areas only, and you must pick up after your dogs & put into garbage cans.

- BEST OF BREED CLASS: Best of Breed competition is only for dogs that are ABIDS & FCI Champions a copy of FCI Championship must accompany your Entry Form. If according to owners or agents records your dog has completed the requirements for ABIDS Championship but Championship has not yet been confirmed by ABIDS office yet your win may be forfeited if no ABIDS Championship is actually acquired.
- 2. All dogs must be entered in the name of the person who actually owned it at the time of the pre-entry for the show. If a registered dog has been acquired by a new owner, it must be entered in the name of the new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owners have received the registration certificate indicating that the dog is recorded in their name. State on entry form whether transfer application has been mailed to parent club or FCI.
